AN ORDINANCE REQUIRING ALL DRIVERS AND OPERATOR OF JEEPNEYS AND PASSENGER BUSES PLYING THE ROUTE OF MATNOG TO INSTALL A SUITABLE TRASH CONTAINER INSIDE THEIR VEHICLE

BE IT ORDAINED by the Sangguniang Bayan of Matnog Sorsogon that :

Section 1. Prohibition No Bus or jeepney is permitted to operate in this municipality without a suitable trash container inside the vehicle.

Section 2. Penal Provision. Any driver and Operator of any bus and jeepney plying the route of Matnog who violates any provision of this ordinance shall be made to pay a fine as follows :

Section 3. Person Authorized in the Enforcement of this Ordinance. The local Philippine National Police and the Municipal Treasurer are hereby deputized in the enforcement of this ordinance.

Section 4. Repealing Clause. Any ordinance, rules and regulations or parts thereof which are inconsistent or in conflict with the provisions of this ordinance are hereby repealed and /or modified accordingly.

Section 5. Separability Clause. If for any reason, any section or provision of this ordinance is held to be unconstitutional or invalid, no other section or provision hereof shall be affected.

Section 6. Effectivity. This ordinance shall take effect at the end of the period of posting of three (3) Consecutive weeks at prominent places in the municipality of Matnog .

AN ORDINANCE REQUIRING ALL DRIVERS AND OPERATOR OF JEEPNEYS AND PASSENGER BUSES PLYING THE ROUTE OF MATNOG TO INSTALL A SUITABLE TRASH CONTAINER INSIDE THEIR VEHICLE

BE IT ORDAINED by the Sangguniang Bayan of Matnog Sorsogon that :

Section 1. Prohibition No Bus or jeepney is permitted to operate in this municipality without a suitable trash container inside the vehicle.

Section 2. Penal Provision. Any driver and Operator of any bus and jeepney plying the route of Matnog who violates any provision of this ordinance shall be made to pay a fine as follows :

First offense	P 50.00
Second offense	100.00
Third and succeeding offenses	200.00

Section 3. Person Authorized in the Enforcement of this Ordinance. The local Philippine National Police and the Municipal Treasurer are hereby deputized in the enforcement of this ordinance.

Section 4. Repealing Clause. Any ordinance, rules and regulations or parts thereof which are inconsistent or in conflict with the provisions of this ordinance are hereby repealed and /or modified accordingly.

Section 5. Separability Clause. If for any reason, any section or provision of this ordinance is held to be unconstitutional or invalid, no other section or provision hereof shall be affected.

Section 6. Effectivity. This ordinance shall take effect at the end of the period of posting of three (3) Consecutive weeks at prominent places in the municipality of Matnog .
