AN ORDINANCE PRESCRIBING A NEW SCHEDULE OF PASSENGER FARE RATES FOR MOTORIZED TRIMOBILES WITHIN THE MUNICIPALITY OF MATNOG, AMENDING MUNICIPAL ORDINANCE NO. 03-2004

BE IT ORDAINED By the Sangguniang Bayan of Matnog, That:

Section 1. This ordinance shall be known as the New Schedule of Fare Rates for motorized Trimobiles within the Municipality of Matnog and an amendment to pertinent provisions of the existing Municipal Ordinance No. 03-2004.

Section 2. Schedule of Fare Rates of motorized Trimobiles:

- C.** A four (P4.00) Pesos tariff shall be charged upon every 50 kilogram baggage/cargo for the first two kilometers. Ten (.10) centavos shall be charged additionally to every additional kilo weight to the cargo. A charged of Fifty (.50) centavos shall be imposed for every additional kilometer or any fraction thereof to the distance traveled.

ORDAINED FURTHERMORE, that:

public utility shall be provided with the schedule of fare rates which the operator or driver shall put on display prominently inside the vehicle.

1. First Offense- a fine of P200.00 and One (1) week suspension of the driver violator from using Any trimobile within the municipality.
2. Second Offense- a fine of P300.00 and One (1) month suspension of the driver violator From using any trimobile for hire within the municipality.
3. Third Offense- a fine of P500.00 and three (3) months suspension of the driver violator From using any trimobile for hire within the municipality. It shall also be the right of the municipal Government to confiscate and revoke the MTOP of the vehicle.
4. All vehicles of all driver violators apprehended for overcharging shall be impounded under the Jurisdiction of the local PNP until such time that the financial penalties due are paid.

Section 4. Repealing Clause. Any ordinance, rule and regulation or part thereof which is inconsistent or in conflict with any of the provisions of this ordinance is hereby repealed or modified accordingly.

Section 5. Effectivity. This ordinance shall take effect after posting in three conspicuous places in the municipality or after publication in a newspaper of general circulation both for a period of three consecutive weeks.

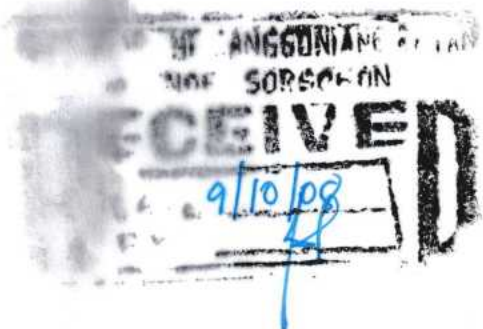
