RESOLUTION ENACTING AN ORDINANCE PROHIBITING ANY CITIZEN FROM URINATING IN PUBLIC PLACES SUCH AS RIZAL PARK, JEEPNEY/BUS TERMINAL AND OTHER SIMILAR PLACES WITHIN THE MUNICIPALITY OF MATNOG, SORSOGON.

WHEREAS, front of the Municipal Building and Rizal Park is the parking area of different jeepneys and buses;

WHEREAS, passengers of the said vehicles are just urinating in some corners of the said public places particularly on the entrance of the Rizal Park which is the nearest hidden corner near the parking area;

WHEREAS, continuous urinating in the said places create unpleasant odor which is not fit for the Health and Sanitation of the community;

WHEREFORE, on motion presented by Kgd. Alex B. Dulay duly seconded by Kgd. Rufino G. Oro, be it

RESOLVED, AS IT IS HEREBY RESOLVED, to enact as it is hereby enacted:

Municipal Ordinance No. 03-94

AN ORDINANCE PROHIBITING ANY CITIZEN FROM URINATING IN PUBLIC PLACES SUCH AS RIZAL PARK, JEEPNEY/BUS TERMINAL AND OTHER SIMILAR PLACES WITHIN THE MUNICIPALITY OF MATNOG, SORSOGON.

BE IT ORDAINED by the Sangguniang Bayan of Matnog, that:

Section 1. Prohibition. it shall be unlawful for nay person or citizen to just urinate in public places such as Rizal Park, Jeepney/Bus Terminal and other similar places within the Municipality of Matnog, Sorsogon.

Section 2. Persons Authorized to Enforce this Municipal Ordinance. members of the Barangay Tanod and Barangay Officials in the Municipality of Matnog, Sorsogon are hereby deputized in the enforcement of this ordinance.

Section 3. Penal Provision. Violation of any of the provision of this Municipal Ordinance shall subject to the offender to a fine of not less than one Hundred (P100.00) pesos but not more than Five Hundred (P500.00) pesos or imprisonment of not less than one(1) day but not exceeding one(1) week.

Section 4. Separability Clause. If for any reason, any section or provision of this Municipal Ordinance is held unconstitutional or invalid no other section or provisions hereof shall be affected.

Section 5. Effectivity. This Municipal Ordinance shall take effect at the end of the period of posting of three (3) consecutive weeks at prominent places in the Municipality of Matnog, Sorsogon particularly on the said public places.
