RESOLUTION NO. 389-2020



RESOLUTION REMANDING MATNOG MUNICIPAL ORDINANCE NO. 2020-02 – AN ORDINANCE CREATING THE POSITIONS OF COLLEGE ADMINISTRATOR, SG 24; COLLEGE LIBRARIAN, SG 13; COLLEGE INSTRUCTOR, SG 12; COLLEGE REGISTRAR, SG 11; COLLEGE NURSE, SG 10 AND COLLEGE GUIDANCE COUNSELOR, SG 10 AT MATNOG COMMUNITY COLLEGE.

WHEREAS, the Sangguniang Panlalawigan of Sorsogon was in receipt of Matnog Municipal Ordinance No. 2020-02 for review and appropriate action;

WHEREAS, the joint Committee on Civil Service and Professional Regulations and the Committee on Budget and Appropriations conducted a hearing on July 29, 2020;

WHEREAS, the passage of the ordinance is within the power of the sangguniang bayan as provided under Section 447 (a) (1) (viii) of RA 7160 which states that the sangguniang bayan, as the legislative body of the municipality shall *“Determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the municipal government”*;



WHEREAS, the original plan for the effectivity of the ordinance is CY 2020, but because of the COVID-19 pandemic the LGU decided to use the funds instead in the campaign against the pandemic. Thus, the ordinance will be implemented next year. Also based on the assistant

Personnel Services limitation and is allowed to create the intended positions. However, the computation might change if the ordinance would take effect next year;

WHEREAS, the assistant provincial budget officer said the ordinance is not under the economic enterprise and can be sourced out from the General Fund. She added that the Municipality of Matnog is a third-class municipality, and the qualifications provided in the ordinance should be in accordance with the provisions of Local Budget Circular No. 53 dated September 1, 1993. The following are the proposed corrections on Section 2 of the ordinance:

- a. The position College Administrator, SG 24 shall be Assistant College Department Head, SG 17
- b. The position College Instructor shall be Instructor I
- c. The position College Registrar shall be Registrar I
- d. The position College Nurse I, SG 10 shall be Nurse I, SG 15;

WHEREAS, the following are the changes and some observations in the ordinance:

- a. The appropriation shall be taken from the General Fund
- b. The Effectivity Clause of the ordinance should be in accordance with the provisions of Section 59 of RA 7160, which provides the requisites for the effectivity of resolutions or ordinances. Thus, the Effectivity Clause may be revised to read as: "*This Ordinance shall take effect ten (10) days from the date a copy thereof is posted in a bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the local government unit*";

NOW, THEREFORE on motion of Hon. Francisco L. Ravanilla, duly seconded by Hon. Roland R. Añonuevo, the Board **RESOLVED**, as it is hereby **DONE**, to **REMAND MATNOG MUNICIPAL ORDINANCE NO. 2020-02 – AN ORDINANCE CREATING THE POSITIONS OF COLLEGE ADMINISTRATOR, SG 24; COLLEGE LIBRARIAN, SG 13; COLLEGE INSTRUCTOR, SG 12; COLLEGE REGISTRAR, SG 11; COLLEGE NURSE, SG 10 AND COLLEGE GUIDANCE COUNSELOR, SG 10 AT MATNOG COMMUNITY COLLEGE.**
