MUNICIPAL ORDINANCE NO. 2025-14

AN ORDINANCE AMENDING ARTICLE M SECTION 4 OF MUNICIPAL ORDINANCE NO. 06-2017 OR THE REVISED REVENUE CODE OF THE MUNICIPALITY ENTITLED: AN ORDINANCE IMPOSING USERS FEE ON ALL VEHICLES BOUND FOR VISAYAS AND MINDANAO UTILIZING THE MATNOC INTEGRATED TRANSPORT TERMINAL (MITT) IN MATNOC, SORSOGON

BE IT ORDAINED by the Sangguniang Bayan of Matnog, Sorsogon, that:

Section 1. Imposition of Fee. There shall be collected a **User's fee** on all vehicles bound for Visayas and Mindanao utilizing any designated parking or holding area, whether owned, leased to or rented by the Local Government Unit of Matnog Sorsogon.

Section 2. Scope. This Ordinance shall apply to all vehicles utilizing any designated parking or holding area whether owned, leased to, or rented by the Local Government Unit of Matnog, Sorsogon bound to Visayas and Mindanao.

Section 3. Definition of terms: For purposes of this ordinance, the following terms are defined as follows:

- a. **Bicycle** - vehicles consisting of a light frame mounted on two wire-spoked wheels one behind the other and having a seat, handlebars for steering, brakes and two pedals or small motor by which it is driven.
- b. **Bus**- a long motor vehicle for carrying passenger, usually a long fixed route.
- c. **Motorcycle** - a two-wheeled (or if equipped with a side-car, three-wheeled) vehicle propelled by internal combustion engine and resembling a bicycle, but larger and heavier, and often having two saddles.
- d. **Small vehicle** - with carrying capacity of not more 13 passengers.
- e. **Sidecar** - a one-wheeled car for a single passenger attached to the side of a motorcycle
- f. **Truck** - 3 seating capacity such as forward, 6 wheelers, 10 wheeler.
- g. **Trailer** - at least 20 footer length.

Section 4. imposition. The following entry fees are hereby amended as follows:

Trailer	150.00
Truck	100.00
Bus	70.00
Small vehicle	50.00
Motorcycle with sidecar	40.00
Motorcycle	30.00
Bicycle with sidecar	20.00
Bicycle	10.00

Section 5. Penalties. Drivers violating any provision of this ordinance shall be made to pay a fine or shall be punished as follows:


First offense	500.000
Second offense	1,000.00
Third offense	2,500.00 and/or imprisonment not more than six (6) months upon discretion of the Court

Section 6. Disposition of fees. All collected fees shall be utilized for the LGU's Program Development and Social services , Projects and Programs.

Section 7. Separability Clause. If any part of this ordinance is declared as unconstitutional or unlawful, such declaration shall not affect or section hereof that are not declared unlawful or unconstitutional.

Section 8. Repealing Clause. All Previous ordinances inconsistent with this ordinance shall be deemed repealed or modified accordingly.
