RESOLUTION NO. 47-2012

RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 04-2011, OF THE MUNICIPALITY OF MATNOG, SORSOGON OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS.

WHEREAS, Appropriation Ordinance No. 04-2011 of the Municipality of Matnog, Sorsogon, authorizing its Supplemental Budget No. 2 for FY 2011 involving an appropriation of P2,150,000.00 was submitted to this Sanggunian for review on December 19, 2011, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, Appropriation Ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations, except for the non-submission of Budget Message for the Ordinance submitted and that payment of Productivity Enhancement Incentive (PEI) should be in accordance with the prescribed guidelines of Budget Circular No. 2011-04, dated December 5, 2011.

NOW, THEREFORE, on motion of Hon. Bernard H. Hao, duly seconded by Hon. Angle E. Escandor,

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 04-2011 of the Municipality of Matnog, Sorsogon OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS, effective as of the date fixed in its enabling ordinance, subject to the posting requirements under Section 59 of RA 7160, and subject however to the conditions stated above.

RESOLVED FURTHER, to require the Municipality to comply with the herein conditions and notify this body of action taken thereon.



RESOLVED FURTHER, to inform the Municipality that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of the Municipality of Matnog, Sorsogon.
