WHEREAS, submitted to the Sangguniang Panlalawigan of Sorsogon is **MATNOG MUNICIPAL ORDINANCE NO. 2025-14: AN ORDINANCE AMENDING ARTICLE M SECTION 14 OF MUNICIPAL ORDINANCE NO.06-2017 OR THE REVISED REVENUE CODE OF THE MUNICIPALITY ENTITLED: AN ORDINANCE IMPOSING USERS FEE ON ALL VEHICLES BOUND FOR VISAYAS AND MINDANAO UTILIZING THE MATNOG INTEGRATED TRANSPORT TERMINAL (MITT) IN MATNOG**, Sorsogon for review and appropriate action;

WHEREAS, the ordinance aims to amend the entry fees provided in Section 4 of Municipal Ordinance No. 06-2017, by increasing the amount corresponding the different types of vehicles entering the MITT. The increase is justified by the acceleration of the inflation rate

in the country, which in turn affects the capacity of the LGU to maintain the MITT. The meager resources of the LGU necessitate them to look for other sources of revenue to sustain and maintain the operation of the MITT. Thus, the minimal increase in the entry fees is reasonable;

WHEREAS, the subject ordinance is within the powers of the Sangguniang Bayan of Bulan as provided under the Local Government Code of 1991. Hence it is *intra vires*;

NOW, THEREFORE, on motion of Hon. Luis C. Leosala, Jr. jointly seconded by Hon. Rommel John C. Mella and Hon. Benito L. WHEREAS, submitted to the Sangguniang Panlalawigan of Sorsogon is **MATNOG MUNICIPAL ORDINANCE NO. 2025-12: AN ORDINANCE IMPOSING AN ENVIRONMENTAL MANAGEMENT PARTICIPATORY FEE (EMP) TO ALL TRAVELERS PASSING THROUGH THE MUNICIPALITY OF MATNOG, SORSOGON AND BOUND TO VISAYAS AND MINDANAO** for review and appropriate action;

WHEREAS, the subject ordinance aims to impose an Environmental Management Fund fees to all travelers passing through the Municipality of Matnog and bound to Visayas and Mindanao in order to sustain a clean and healthy environment and enhance economic prosperity within their territorial jurisdiction;

WHEREAS, the august body recommends the following:

- a) In Section 6 (a), limit the exemption to bona fide residents of the Municipality of Matnog only.
- b) In Section 8, the EMP fee should accumulate to the General Fund, instead of putting the collection under a Trust Fund, with the advice that a reasonable portion thereof should be utilized for the effective implementation of the ordinance, as provided in the said section. (Utilization of Fund);

WHEREAS, the subject ordinance is within the powers of the Sangguniang Bayan of Bulan as provided under the Local Government Code of 1991. Hence it is *intra vires*;

NOW, THEREFORE, on motion of Hon. Luis C. Leosala, duly seconded by Hon. Ramil M.
