RESOLUTION NO. 578-2023

RESOLUTION DISAPPROVING MATNOG APPROPRIATION ORDINANCE NO. 2023-01, ENTITLED: "AN ORDINANCE APPROVING SUPPLEMENTAL BUDGET NO. 1 APPROPRIATING THE AMOUNT OF FOUR MILLION ONE HUNDRED SEVENTY-EIGHT THOUSAND ONE HUNDRED SEVENTY-SEVEN [sic] AND 54/100 (P4,178,177.54) FROM SAVINGS FOR SALARIES OF VACANT POSITIONS AT THE MATNOG COMMUNITY COLLEGE AND VACANT POSITIONS FOR MUNICIPAL AGRICULTURAL OFFICER ASSISTANT MUNICIPAL ASSESSOR TO PROVIDE ADDITIONAL APPROPRIATION FOR OTHER MAINTENANCE AND OPERATING EXPENSES AT THE OFFICE OF THE MAYOR."

WHEREAS, submitted to the Sangguniang Panlalawigan of Sorsogon was Matnog Appropriation Ordinance No. 2023-01 for review and appropriate action;

WHEREAS, the Board made the following findings:

1. In the supplemental budget itself, the amount P3,213,855.54 is appropriated to the Other Maintenance and Operating Expenses (OMOE) of the Office of the Mayor. Nowhere in the subject appropriation ordinance was the Kadunungan Program mentioned nor was it the subject of expenditure. It contradicts the claim of the

Municipal Budget Officer that the amount is appropriated as part of 40% share of the LGU for the implementation of the Kadunungan Program in the municipality;

2. The savings from salaries of various vacant mandatory positions in the Matnog Community College need not be the source of appropriation. The school is undergoing evaluation for the grant of its Institutional Recognition as stated under Commission on Higher Education Memorandum Circular No. 18-2022 (CHED MC No. 18-2022). If said mandatory positions were unfunded, the grant of Institutional Recognition may be jeopardized.

NOW, THEREFORE, on motion of Hon. Edmundo A. Atutubo, jointly seconded by Hon. Jose Arturo D. Enano and Hon. Lorenz S. Abenion, the Board **RESOLVED**, as it is hereby **DONE**, to **DISAPPROVE MATNOG APPROPRIATION ORDINANCE NO. 2023-01, ENTITLED: "AN ORDINANCE APPROVING SUPPLEMENTAL BUDGET NO. 1 APPROPRIATING THE AMOUNT OF FOUR MILLION ONE HUNDRED SEVENTY-EIGHT THOUSAND ONE HUNDRED SEVENTY-SEVEN [sic] AND 54/100 (P4,178,177.54) FROM SAVINGS FOR SALARIES OF VACANT POSITIONS AT THE MATNOG COMMUNITY COLLEGE AND VACANT POSITIONS FOR MUNICIPAL AGRICULTURAL OFFICER ASSISTANT MUNICIPAL ASSESSOR TO PROVIDE ADDITIONAL APPROPRIATION FOR OTHER MAINTENANCE AND OPERATING EXPENSES AT THE OFFICE OF THE MAYOR."**
