RESOLUTION NO. 663-2023

RESOLUTION DECLARING INVALID MATNOG ORDINANCE NO. 2023-08, ENTITLED: “AN ORDINANCE ADOPTING THE NEW CHILDHOOD CARE AND DEVELOPMENT PROGRAM AND CONVERTING DAY CARE SERVICES TO QUALITY EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) APPROPRIATING FUNDS THEREFORE AND FOR OTHER PURPOSES.”

WHEREAS, submitted to the Sangguniang Panlalawigan of Sorsogon was Matnog Ordinance No. 2023-08 for review and appropriate action;

WHEREAS, upon careful review, a significant issue was identified in Matnog Ordinance No. 2023-08. The ordinance fails to specify the exact amount or appropriation intended for the implementation of its provisions as required in by Section 7 of the ordinance which stipulates the appropriation of funds for the ECCD program crucial for its successful implementation. Unfortunately, the lack of a specific amount or allocation in the ordinance may affect its enforceability. This deficiency jeopardizes the realization of the ECCD program's goals and compromises the effectiveness of the intended services;

WHEREAS, considering the significant deficiency in the current ordinance, there is a need for an immediate crafting and passage of a new ordinance that incorporates the necessary revisions, including a well-defined budgetary allocation for the ECCD program;

NOW, THEREFORE, on motion of Hon. Roland R. Añonuevo, unanimously seconded, the Board **RESOLVED**, as it is hereby **DONE**, to **DECLARE INVALID MATNOG ORDINANCE NO. 2023-08, ENTITLED: "AN ORDINANCE ADOPTING THE NEW CHILDHOOD CARE AND DEVELOPMENT PROGRAM AND CONVERTING DAY CARE SERVICES TO QUALITY EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) APPROPRIATING FUNDS THEREFORE AND FOR OTHER PURPOSES."**
