**RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 03 SERIES OF 2010 OF THE MUNICIPALITY OF MATNOG, SORSOGON OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS.**

**WHEREAS**, Appropriation Ordinance No. 03, SERIES OF 2010 of the Municipality of Matnog, Sorsogon authorizing Supplemental Budget No. 02 involving an appropriation of P200,000.00, was submitted to this Sanggunian for review on October 22, 2010, pursuant to the provisions of Republic Act (R.A.0 No. 7160;

**WHEREAS**, subject Appropriation Ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations except for the following;

1. That the reversion/realignment of previously authorized appropriation should not prejudice nor jeopardize its original intent.
2. That disbursement of Capital Outlay expenses should be in accordance with the provisions of RA 9184 and its Implementing Rules and Regulations as amended.
3. That disbursement of all appropriations herein authorized should be subject to the usual accounting and auditing rules and regulations.
