WHEREAS, submitted to the Office of the Sangguniang Bayan were the Appropriation Ordinance of Barangay Gadgaron, Sisigon, Bon-ot Small, Sulangan, Manjumlad and Calpi all of Matnog, Sorsogon;

WHEREAS, the same were referred to the Committee on Finance, Budget, Appropriations and Ways and Means which reported back with the following findings and recommendation, to wit:

**FINDINGS:**

1. On Appropriation Ordinance No. 04-2017 of Barangay Sisigon, appropriating the amount of Thirty Seven Thousand Eight Hundred Ninety Six Pesos & 01/100 (37,896.01) taken from the Savings CY 2016 to be utilized for the Cash Gift of Barangay Officials amounting to 20,000.00, Travel amounting to 5,896.01 and other Services of the barangay amounting to 12,000.00 is proper and in order. Breakdown of the amount for the bonus of Barangay was not incorporate in the said ordinance.
2. Appropriation Ordinance No. 02-2017 of Barangay Bonot Small appropriating the amount of Thirty Three Thousand Six Hundred Eighty Three Pesos (33,683.00) taken from the Savings CY 2016 of SK Honoraria, amounting to 22,673.00, BHW, 237.00, Lupon, -13,200.00 Insurance-2,555.00, other Services- 106.00, RPT share 312.00, Municipal Aid-2,000.00 and Provincial Aid 2014 & 2016 -4,000.00 to be utilized for the purchase of laptop with printer is not proper therefore said Appropriation ordinance No. 02-2017 is declared in valid.
3. Appropriation Ordinance No. 02-2017 of barangay Manjumlad, appropriating the amount of Twenty One Thousand Six Hundred Forty Nine & 45/100 Pesos taken from savings CY 2016 to be utilized for other services of the barangay is proper and in order.
4. Appropriation Ordinance No. 02-2017 of Barangay Sulangan, appropriating the amount of Twenty Six Thousand Four Hundred Seventy Nine Pesos & 88/100 (26,479.88) taken from Savings CY 2016 of SK Honoraria-5,340.00, Terminal leave-550.00, Travel-500.00, BHW-12,000.00, Office supplies- 100.00, RPT share-1,989.88, Municipal Aid-2,000.00 and Provincial Aid-4,000.00 to be utilized for other services and Bonus of barangay Officials is proper and in order provided that all savings from SK Honoraria amounting to 5,340.00 must be utilized for the bonus of official.
5. Resolution No. 6 s. 2017 of barangay Calpi, realigning the amount of Two Hundred Seven Thousand Eight Hundred Ninety Three Pesos (207,893.00) taken from BDF 2017 under repair/rehabilitation of toilet be utilized for installation of solar Street lights and additional public toilet of Calpi is proper and in order.
6. Resolution No. 16 s. 2017 of barangay Gadgaron realigning tbe amount of Nine Thousand Two Hundred Seventy Four & 14/100 from the 20 BDF under construction of comfort room and day care center be utilized for the counterpart of the barangay to the Kalahi project at the barangay is proper and in order.

7. Resolution No. 09 s. 2017 of barangay Bonot Small realigning the amount of Twenty Seven Thousand Eight Hundred Eighty Eight Pesos (27,888.00) from the SK Honoraria from January to July, 2017 to be utilized for the cash gift of appointed and elective officials of the barangay is proper and in order .

### **K. CALENDAR OF BUSINESS**

K.1. Letter of invitation to Arch. Joselito S. Garrido, MPDO re: Status of Comprehensive Land Use Plan (CLUP) of Matnog, Sorsogon

On motion of Honorable Ernie G. Garcera the rules on deliberation was suspended to allow participation of Arch. Joselito Garrido, MPDO on the status of the CLUP.

Honorable Ernie Garcera stated the MNHS is needing space for the construction of classrooms but he understands portion of that the lot covered by Presidential Proclamation 415 is given to the MTC, BOF, PNP, RHU, PA, NHA and the construction of the LGU building.

Arch. Garrido said that per resolution No. 117 s. 2015, the SB authorized for the donation of a 2,200 sq m for Matnog National High School. So the reserved area for MNHS is only 2,200 sq m. what is possible to do is to apply for a new expansion site in order to accommodate the clamor for additional area. Honorable Emilio G. Ubaldo, III said that Arch. Garrido knows the process of application for town expansion site. On the question of Honorable Recto Dulay as to the targeted additional area, Arch. Garrido said that it is 10 hectares.

As to the status of the CLUP, Arch. Garrido said that the municipalities of Magallanes, Bulusan and Juban submitted their respective CLUP to the Provincial land Use Committee (PLUC) but the same was returned on the ground that the plan for water and forest should be included thereat. "The problem with our CLUP is the mapping. I even told the Technical Working Group (TWG) to explain to the Sangguniang Bayan (SB) why it is taking them so long. As to the funding, he informed the body that it is an ARCP project and it is not yet downloaded. There is no cash out. On the question of Honorable Celerina Cecil Ubaldo if on the new CLUP, plan for the water is already included, Arch. Garrido said that it is not yet included due to the dispute with Sta. Magdalena as to water boundaries. Honorable Emilio Ubaldo, III said that the LGU should now pursue what it owned.

Arch. Garrido then informed the body that last week the NAMRIA has established the Matnog-Bulan water boundaries . He also said that per latest survey of the DENR, adding up, the municipalities of Bulan, Irosin and Sta. Magdalena has overlapped Matnog with 1,600 hectares.

On the question of Honorable Emilio G. Ubaldo if the dumping of soil at the pier has a zoning clearance, Arch. Garrido said that it has none. Honorable Ubaldo said that the Sangguniang Bayan has passed a resolution for the stoppage of the activity. He then asked if Arch Garrido is familiar with the approved foreshore delineation. Arch. Garrido said that the first delineation in Tabunan. Now it is seaward. He said that he will provide a copy for the SB.

As to the holding area in Pawa, Honorable Emilio Ubaldo, III asked if the funding came from the 20% Development Plan. Arch Garrido said that it is on a lease contract under the name of Glen Gacis. The SB Secretary was asked by Honorable Emilio Ubaldo, III if, on record, there is a resolution authorizing the municipal mayor for the particular project. The SB Secretary said that per record, there is none. Additional information was given that there exists a resolution authorizing the mayor to transact all bonds, contracts x x x for and in behalf of the municipality. Honorable Emilio Ubaldo, III said that the resolution says that it is still subject to the approval of the Sangguniang Bayan.

Honorable Ernie Garcera presented a resolution, of which he is the author, per request by Honorable Claudith So, to authorize her to enter in to a Memorandum of Agreement between and among the municipalities of Irosin, Bulan, Sta. Magdalena and the Province of Sorsogon, regarding the establishment and implementation of the Local Climate Change Action Plan (LCCAP) on the convergence mode. He also said that he would like to take the opportunity of the presence of Arch. Garrido on the ground that he has more knowledge about the same. Arch. Garrido said that during their meeting in Bulan on July 28<sup>th</sup>, they were informed of the same and that the lead person is under the Office of the President thru the Climate Change Commission. In the Province of Sorsogon, it is spearheaded by Board Member Arze Glipo. Sorsogon is the pilot province but due to its hard geographic location the four municipalities were chosen as the pilot group. It was decided that 1 plan shall be adopted. It has a large amount of fund but it can never be funded out without the LCCAP. The Local Climate Change Action Plan (LCCAP) is a document on how to access funding from international agencies. It also covers plans to be implemented on how to combat climate change which causes flood, erosion and effects in agriculture. On the question of Honorable Emilio G. Ubaldo, III as to the counterpart of the municipality, Arch. Garrido said that the counterpart shall be in the form of technical personnel.

There having no more questions made, the same was approved, thus:
