**RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 07-2018 OF THE MUNICIPALITY OF MATNOG, SORSOGON OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS.**

**WHEREAS**, Appropriation Ordinance No. 07-2018 of the Municipality of Matnog, Sorsogon authorizing its Supplemental Budget No. 5 for Fiscal Year 2018 involving an appropriation of P1,496,850.00 was submitted to this Sanggunian for review on December 20, 2018 for review pursuant to the provisions of RA 7160;

**WHEREAS**, subject appropriation ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations subject to the following conditions:

1. *That this submitted budget should be numbered Supplemental Budget No. 5;*
2. *That reversion of previously authorized appropriations should not prejudice valid claimant if there is any nor jeopardize its original intent;*
3. *That the grant of PEI should be in accordance with Budget Circular No. 2017-04 dated April 4, 2017;*
4. *That the appropriation intended for Other MOOE and Other General Services should be subject to the provisions of Sec. 305(b) and 335 of RA 7160;*
5. *That disbursement of appropriations herein authorized should be subject to the usual accounting and auditing rules and regulations.*

**NOW, THEREFORE**, on motion of Hon. Maria Teresa G. Fragata, duly seconded by Hon. Renato "Joey" V. Guban, the Board **RESOLVED**, as it is hereby **DONE**, to **DECLARE APPROPRIATION ORDINANCE NO. 07-2018 OF THE MUNICIPALITY OF MATNOG, SORSOGON OPERATIVE IN ITS ENTIRETY** subject, however, to the conditions stated above, effective as of the date fixed in its enabling ordinance, and subject to the posting

**RESOLVED FURTHER**, to require the Municipality to comply with the herein conditions and notify this body of actions taken thereon;


**RESOLVED FINALLY**, to inform the Municipality that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.
