RESOLUTION ENACTING AN ORDINANCE AMENDING RESOLUTION NO. 06 S. 1994, FURTHER EMBODIED IN SECTION 74 ARTICLE XIII OF MUNICIPAL TAX ORDINANCE NO. 06-2000 OTHERWISE KNOWN AS THE MUNICIPAL TAX ORDINANCE OF MATNOG, SORSOGON

WHEREAS, Section 129 of the Local Government Code of 1991 provides that each local government unit shall exercise its power to create its own sources of revenue and to levy taxes, fees and charges;

WHEREAS, it is also provided that such taxes, fees and charges shall accrue exclusively to the local government unit and that the same shall be used solely for public purposes to the benefit of and subject to the disposition of the Local Government Unit of Matnog, Province of Sorsogon;

WHEREAS, the LGU of Matnog is wanting in financial capacity to maintain its facilities which are directly utilized by passengers surrounding the port area;

WHEREAS, there is an immediate necessity to assist the Philippine Ports Authority in its prime function in maintaining and providing orderly and peaceful port area and its nearby surroundings;

WHEREFORE, on motion of Hon. Jaime Gata, Jr. duly seconded by Hon. Romeo Garalde, Hon. Romeo Garrido and Hon. Carlos G. Estrelon, Jr., be it

RESOLVED, AS IT IS HEREBY RESOLVED, to enact as it is hereby enacted

AN ORDINANCE AMENDING RESOLUTION NO. 06 S. 1994, FURTHER EMBODIED IN SECTION 74 ARTICLE XIII OF MUNICIPAL TAX ORDINANCE NO. 06-2000 OTHERWISE KNOWN AS THE MUNICIPAL TAX ORDINANCE OF MATNOG, SORSOGON

BE IT ORDAINED by the Sangguniang Bayan of Matnog, Sorsogon that:

Section 1. Amendment. Section 74 of Article XIII of the Municipal Tax Ordinance of Matnog, Sorsogon shall now be amended, as it is hereby amended as follows:

Section 74. THERE SHALL BE COLLECTED A REGULATORY FEE OF THREE (P3.00) PESOS ONLY FOR EVERY PASSENGER BOARDING THE FERRY BOATS FROM MATNOG PORT BOUND FOR SAMAR.

Section 2. Disposition of the Collected Regulatory Fee. Seventy (70%) percent shall be utilized dependent upon the needs of the LGU of Matnog, Sorsogon in its operation and delivery of basic services and the remaining Thirty (30%) percent shall be utilized solely for the maintenance of facilities in the port area and nearby surroundings.


Section 3. Repealing Clause. Any ordinance, rule and regulation or part thereof, which are inconsistent or in conflict with any of the provisions of this Municipal Ordinance is hereby repealed or modified accordingly. Provided, that if, for any reason, any section or provision of this ordinance shall be held unconstitutional or invalid, no other section or provision hereof shall be affected thereby.


Section 4. Effectivity. This Ordinance shall take effect on the day following its publication in newspaper of general circulation within the province of Sorsogon and/or at the end of the period of posting for three (3) consecutive weeks at three conspicuous places in the municipality, whichever occurs later.
