## **RESOLUTION NO. 266-2018**

**RESOLUTION DECLARING VALID MATNOG MUNICIPAL ORDINANCE NO 02-2018 ENTITLED: "AN ORDINANCE MANDATING INSTALLATION OF CLOSED CIRCUIT TELEVISION (CCTV) CAMERAS IN GOVERNMENT OFFICES, BARANGAYS AND BUSINESS ESTABLISHMENTS WHETHER PRIVATE OR PUBLIC OPERATING WITHIN THE MUNICIPALITY OF MATNOG AND PROVIDING PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES."**

**WHEREAS**, submitted for consideration of the Board was Matnog Municipal Ordinance No. 02-2018;

**WHEREAS**, the enactment of the ordinance is unchored on the General Welfare clause or Section 16 of RA 7160 known as the Local Government Code of 1991 which provides among others that local government units shall ensure the safety of its constituents, maintain peace and order and preserve the comfort and convenience of their inhabitants;

**WHEREAS**, safety measures against substandard installation, operation and maintenance of said CCTV as well as against possible abuse of its utilization are provided in the ordinance under Sections 6, 7, 8, 9, 10 and 11 thereof. These provisions will ensure that the prescribed specifications of the materials/equipment will be strictly complied to avoid penalties;

**WHEREAS**, the Board finds subject ordinance *intra vires* as mandated by the Local Government Code of 1991;





