RESOLUTION NO. 27-2021

RESOLUTION DECLARING APPROPRIATION ORDINANCE NOS. 2020-10 AND 2020-11 OF THE MUNICIPALITY OF MATNOG, SORSOGON OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance Nos. 2020-10 and 2020-11 of the municipality of Matnog, Sorsogon authorizing its Supplemental Budget Nos. 8 and 9 involving the appropriations of Three Million Six Hundred Five Thousand Four Hundred Ninety-Three Pesos and 59/100 (P3,605,493.59) and One Million Eighty Thousand Pesos (P1,080,000.00), respectively, were submitted to this sanggunian for review on January 13, 2021 pursuant to the provision of Republic Act 7160;

WHEREAS, the appropriation ordinances reveal substantial compliance with the same law and implementing rules and regulations, subject to the following conditions:

1. That "Savings" shall refer to portions or balances as of any given point in the fiscal year or any programmed or allotted appropriation which shall remain free of any obligation or incumbrance and which are still available after the satisfactory completion or purpose for which the appropriation was originally authorized or which result from unobligated compensation and related costs pertaining to the vacant positions and leave of absence without pay;
2. That the grant of Service Recognition Incentive (SRI) to all government employees shall conform with the guidelines prescribed under Budget Circular No. 2020-06

(Guidelines on the Grant of the One-Time Service Recognition Incentive to Government Employees for FY 2020), dated December 22, 2020;

3. That the appropriation for 20% Development Fund to be utilized for projects in addressing the COVID-19 pandemic situation in the municipality should be in accordance with the guidelines under DILG-DBM Joint Memorandum Circular No. 1 (Additional Guidelines on the Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment for Development Projects in View of the Coronavirus Disease 2019 (COVID-19) Situation), dated March 27, 2020 and DILG-DOF-DBM Joint Memorandum Circular No. 1, dated November 4, 2020;
4. That all COVID-19 related programs, projects and activities identified to be implemented under these supplemental budgets are included in the approved Annual Investment Program (AIP)/Supplemental Investment Program (SIP) for CY 2020 as per DILG-DBM Joint Memorandum Circular No. 02, dated March 20, 2020;
5. That said appropriation ordinances shall serve as the basis for the disbursement of funds pursuant to Section 346 of RA 7160. Disbursements shall be made in accordance with the approved budgets and shall follow the existing budgeting, accounting and auditing rules and regulations;

NOW, THEREFORE, on motion of Hon. Edmundo A. Atutubo, duly seconded by Hon. Krunimar Antonio D. Escudero II, the Board **RESOLVED**, as it is hereby **DONE**, to **DECLARE APPROPRIATION ORDINANCE NOS. 2020-10 AND 2020-11 OF THE MUNICIPALITY OF MATNOG, SORSOGON OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS**, effective as of the date fixed in its enabling ordinance, subject to the posting requirement under Section 59 of RA 7160 and the conditions stated above;

RESOLVED FURTHERMORE, to require the municipality to comply with the herein conditions and notify this sangguniang panlalawigan of actions taken thereon.

RESOLVED FINALLY, to inform the municipality that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

LET COPIES of this resolution be furnished Provincial Budget Officer Rosie D. Agnis, Mayor Claudith M. So and the Sangguniang Bayan of Matnog, Sorsogon for their information, guidance and appropriate action.




