

RESOLUTION NO. 299-2018

RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 04-2018 OF THE MUNICIPALITY OF MATNOG, SORSOGON OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 01-2018 of the Municipality of Matnog, Sorsogon authorizing its Supplemental Budget No. 3 for FY 2018 involving the appropriation of P3,628,162.00 was submitted to this Sanggunian on October 19, 2018 for review pursuant to the provisions of RA 7160;

WHEREAS, subject Appropriation Ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations subject to the following conditions:

1. *That this submitted budget should be numbered as Supplemental Budget No. 3.*
2. *That the realignment/reversion of previously authorized appropriations should not prejudice valid claimant if ever there is any, nor jeopardize its original intent.*
3. *That appropriation for Donations, Other Expenses and the like should strictly adhere to the provisions of Sections 305 (b) and 335 of RA 7160 which prohibit the use of public funds for religious and private purposes.*
4. *That disbursement of appropriation herein authorized should be subject to the usual accounting and auditing rules and regulations.*

NOW, THEREFORE, on motion of Hon. Maria Teresa G. Fragata, duly seconded by Hon. Benedict T. Hao, the Board **RESOLVED**, as it is hereby **DONE**, to **DECLARE APPROPRIATION ORDINANCE NO. 04-2018 OF THE MUNICIPALITY OF MATNOG, SORSOGON OPERATIVE IN ITS ENTIRETY** effective as of the date fixed in its enabling ordinance, subject to the posting requirements under Section 59 of RA 7160 and subject

RESOLVED FURTHER, to require the Municipality to comply with the herein conditions and notify this body of actions taken thereon;

RESOLVED FINALLY, to inform the Municipality that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

LET COPIES of this resolution be furnished the Honorable Mayor and Sangguniang Bayan of Matnog, Sorsogon for their information and guidance.
