

WHEREAS, Appropriation Ordinance No. 01-2019 of the Municipality of Matnog, Sorsogon authorizing its Supplemental Budget No. 01, series of 2019, involving an appropriation of P8,220,000.00, was submitted to this Sanggunian for review on September 27, 2019 pursuant to the provisions of Republic Act No. 7160;

WHEREAS, subject Appropriation Ordinance reveals substantial compliance with the same law and its implementing Rules and Regulations subject to the following conditions:

1. *Savings shall refer to portions or balances as of any given point in the fiscal year or any programmed or allotted appropriation which shall remain free of any obligation or encumbrance and which are still available after the satisfactory completion or the unavoidable discontinuance or abandonment of the work, activity or purpose for which the appropriation was originally authorized, or which result from unobligated compensation and related costs pertaining to vacant positions and leaves of absence without pay;*

2. That this submitted budget should be numbered as Supplemental Budget No. 1; The grant financial assistance (AICS), Other General Services and Other MOOE should be subject to the provisions of Sec. 305(b) and 335 of RA 7160;
3. That appropriation Capital Outlay (Equipment) should strictly be in accordance with the approved Annual Procurement Plan as provided under RA 9184, its Revised IRR and Administrative Order No. 17 dated July 28, 2011;
4. That disbursement of appropriations herein authorized should be subject to the usual accounting and auditing rules and regulations;

NOW, THEREFORE, on motion of Hon. Edmundo A. Atutubo, duly seconded by Hon. Jose Arturo D. Enano, the Board **RESOLVED**, as it is hereby **DONE**, to **DECLARE THE APPROPRIATION ORDINANCE NO. 01-2019 OF THE MUNICIPALITY OF MATNOG, SORSOGON OPERATIVE IN ITS ENTIRETY**, effective as of the date fixed in its enabling ordinance, subject to the posting requirements under Section 59 of RA No. 7160 and subject however, to the conditions stated above.




