**RESOLUTION NO. 70-2014**

**RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 03-2013 OF THE MUNICIPALITY OF MATNOG, SORSOGON OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS.**

**WHEREAS**, Appropriation Ordinance No. 03-2013 of the Municipality of Matnog, Sorsogon authorizing Supplemental Budget No. 1 CY 2013 involving an appropriation of P1,351,000.00 was submitted to this Sanggunian for review pursuant to the provisions of Republic Act No. 7160;

**WHEREAS**, subject Appropriation Ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations except for the non-submission of the Budget Message for the ordinance submitted and further subject to the conditions, to wit:

1. *That any additional appropriation for Personal Services except for waived items cannot be considered since the Annual Budget already exceeded the PC Cap.*
2. *That sine the source of fund comes from the New Revenue sources, additional appropriation for 5% Calamity Fund should be provided for.*

**NOW, THEREFORE**, on motion of Hon. Bernard H. Hao, duly seconded by Hon. Angel E. Escandor, the Board **RESOLVED**, as it is hereby **DONE**, to **DECLARE APPROPRIATION ORDINANCE NO. 03-2013 OF THE MUNICIPALITY OF MATNOG, SORSOGON OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS** effective as of the date fixed in its enabling ordinance subject to the posting requirements under Section 59 of RA 7160.

**RESOLVED FURTHER**, to require the municipality to comply with the herein conditions and notify this Body of actions taken thereon.

**RESOLVED FURTHER**, to inform the municipality that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

**RESOLVED FINALLY**, to send a copy of this resolution to the Sangguniang Bayan of the Municipality of Matnog, Sorsogon through the Municipal Mayor.


